Disclosure what do I do?:

For those of you whom have participated in the revised Safeguarding Awareness Training you would have been reminded of the 3 R's.

3 R's PROCESS



Reassure: The person that they were right to tell you, and you will help by passing this information on to the appropriate authorities (disclosures cannot remain a secret).

Record: Make a record at the time or as soon as possible—whilst best remembered.

Report: Report all Safeguarding concerns to your Parish Priest, Supervisor, Manager, or the Safeguarding Office. All legal reporting obligations must be complied with, you can seek advice and support from the Safeguarding Office.



NSW Police Force



Make a report to police if the matter involves conduct towards a child that you suspect may be criminal in nature.

For police assistance and general enquiries call 131 444





Department of Communities and Justice (DCJ)



Communities and Justice

Make a report to DCJ if you suspect a child is at risk of significant harm.

Types of abuse include neglect, sexual, physical and emotional.

Notify reportable allegations against staff, certain volunteers and contractors within 7 working days.

Safe Physical and Online Environments:

Physical and online environments promote safety and contain appropriate safeguards to minimise the opportunity for children and adults to be harmed.


Standard 8 of the Australian Catholic Safeguarding Standards focuses on organisations responsibilities to minimise opportunities for abuse to occur, both in physical and online environments.

The Diocese of Lismore Code of Conduct and Safeguarding Children, Young Persons & Adults at Risk Policy outlines appropriate supervision, oversight and behaviour towards children and adults at risk. To view these polices please contact your Parish or the Safeguarding Office.

Risk Management Plans ;- Safeguarding Risk assessments must be conducted on all activities provided within the Diocese that involve children, young people and adults at risk. A Risk Register for each must be kept at the Parish, reviewed and updated (if required) annually if not before. Contact the Safeguarding Office for assistance with developing Risk Management Plans.

especially during National Child Protection Week, the Parish Learning & Development team are running a colouring competition (open to children and adults).


Competition closes Friday 20 September with a prize for a child under 16 and an adult. **So get creative and enter today!**About the competition
